Recent News


SIM Advisory Committee Meeting:

The **SIM Advisory Committee met on May 11th**. During the meeting, DHCF presented the three pillars and four enablers that serve as a framework for the District's State Health Innovation Plan (SHIP). This plan will describe the strategies and methods proposed to transform the structure and performance of the District's entire health system. The three foundational pillars include care delivery, payment reform, and community linkages, which are enabled by stakeholder engagement, health information technology, workforce development, and quality improvement. A draft SHIP will be available for public comment in early June.

Work Group Update:

The **Payment Models Work Group met on May 12th**. During the meeting, stakeholders participated in a straw man exercise that examined three case studies of complex, high-cost, high-need beneficiaries and discussed approaches to better deliver care in order to inform payment reforms. Participants suggested assigning beneficiaries to emergency departments as an approach to reducing inappropriate hospital admissions. In addition, participants also discussed state examples of payment reforms that drive improvements in care delivery. The meeting summary and materials can be found [here](#).

The **Quality Metrics Work Group met on May 16th**. Participants provided feedback on the proposed quality metrics for the District. Stakeholders suggested removing measures that were duplicative and adding measures that would include a broader population base, such as kids and youth. The set of quality measures discussed during the meeting will be recommended to the SIM Advisory Committee for inclusion into the SHIP. Meeting summaries and materials can be found [here](#).



The **Community Linkages Work Group met on May 18th**. The purpose of the meeting was to close the loop on conversations from the first five Community Linkages Work Group meetings in order to develop actionable recommendations for the SIM Advisory Committee to consider. During the meeting, participants discussed questions that should be added to existing assessments used in the District in order to better examine the social determinants of health. CMS Announces Results From Round One Health Care Innovation Awards

The **Centers for Medicare and Medicaid Services (CMS)** shared the second annual independent evaluation reports of round one of the Health Care Innovation Awards. Where data are available, these reports describe preliminary impact estimates on key outcome measures such as hospitalizations and readmissions. A number of awardees showed favorable results on one or more measures of cost, hospitalizations, readmissions, and emergency room visits. In addition, qualitative findings suggest that staff highly value the triage pathways for making their workflow more efficient, and patients greatly appreciate weekend hours and increased capacity for urgent care visits during the day. Health Management Associates will be hosting a webinar on June 28th at 1pm that is titled “Community-Based Participatory Research: How to Identify Social Determinants of Health and Engage Hard-to-Reach Populations in Your Community.” The social determinants of health can be difficult to identify, disproportionately strike hard-to-reach populations, and require targeted responses that engage members and help them stay connected to appropriate services, treatments, and interventions. During this webinar, experts from HMA Community Strategies (HMACS) and the San Francisco Jewish Women’s Fund will outline an initiative to explore qualitatively what the most important needs of a specific population are, and the solutions that they suggest would be helpful. HCP LAN White Papers

The **Health Care Payment Learning & Action Network** released final drafts of two white papers on [patient attribution](#) and [financial benchmarking](#). The paper on patient attribution includes 10 recommendations for designating the population for which a provider will accept accountability in a population-based payment (PBP) model, and documents guiding principles for payers and providers to consider as they integrate patient attribution into their PBP models. The financial benchmarking paper

offers innovative approaches for setting initial benchmarks and updating those benchmarks over time, and suggests considerations for risk adjustment.
