#### MEDICAID DIRECTOR LETTER

SUBJECT: 1915(c) Waiver Renewal: District of Columbia Elderly and Persons with

Physical Disabilities Waiver (0334.R05.00)

## **Purpose**

The purpose of this Medicaid Director Letter (MDL) is to inform all interested parties that the Centers for Medicare and Medicaid Services (CMS) has renewed the District of Columbia's Elderly and Persons with Physical Disabilities Waiver (EPD) for a five-year period, effective February 7, 2022. A formal transmittal detailing the relevant contents of the EPD waiver is forthcoming from the Department of Healthcare Finance (DHCF). In the interim, this MDL highlights information regarding the total amount of personal care aide (PCA) services available to EPD Waiver enrollees.

### **Background**

On October 1, 2020, CMS approved DHCF's EPD Waiver Amendment, which proposed to, in relevant part, limit PCA services to a total of 16 hours per day. On October 28, 2020, DHCF announced that it would be delaying the effective date of the various changes under the EPD waiver amendment that could result in service reductions or terminations due to the COVID-19 public health emergency (PHE), which were subsequently formalized through the CMS-approved 1915(c) Appendix K to the EPD Waiver. Notably, DHCF delayed the provision delinking EPD and State Plan PCA hours, resulting in the limitation to 16 total maximum daily hours of PCA available to EPD waiver enrollees.

#### **Discussion**

On February 7, 2022, CMS approved DHCF's EPD Waiver for a five-year period. Upon further consideration and review, and in close consultation with CMS, DHCF revised the provision limiting the total maximum daily hours of PCA to 16 hours for all EPD waiver enrollees. Under the current approved waiver, enrollees will be able to cumulatively access 24 daily hours of PCA through a combination of 16 daily hours under the EPD waiver, and 8 daily hours under the State Plan, so long as such hours are medically necessary in accordance with the requirements set forth
