**SUBJECT:** DD Waiver January 1, 2023, Rate Correction for Supported Living and Residential Rehabilitation Services

**Purpose**

The purpose of this notice is to communicate an error that was made in the published Appendix K rates for Supported Living and Residential Rehabilitation Services effective January 1, 2023. During the update of the January 2023 rate, the nursing component of the services was increased twice in error, resulting in a higher Per Diem rate than the increase should have been.

**Remedy**

The District is required to pay rates aligned with the approved Appendix K and therefore must correct the error immediately. On June 30, 2023, DHCF will update the impacted rates for the above-mentioned services to reflect the correct rate for the period January 1, 2023, through June 30, 2023.

Claims that were submitted by providers and paid by DHCF using the incorrect rates published by the District will not have to repay the District the amount paid in excess of the correct rate. Those providers will see two adjustments on the Remittance Advice (RA) in the coming weeks. One adjustment will reprocess the payment to reflect an amount that is in excess of what should have been paid. The second adjustment will be an offset to that amount resulting in a net impact of zero

All other claims that have been submitted using codes other than the ones with error (i.e. July 1, 2022 rates) can be resubmitted but will be paid the corrected rate. All claims submitted June 30<sup>th</sup> forward for services rendered January 1 through June 30, 2023, should use the revised rates listed below for proper reimbursement.
