SUBJECT: State Supplementary Payment Level Changes Effective January 1, 2013

The purpose of this transmittal is to inform Community Residential Facility (CRF) Operators that the Department of Health Care Finance (DHCF) has received notification from the Social Security Administration (SSA) indicating that, effective January 1, 2013, the Federal Supplementary Payments will increase by 1.7%.

As a result of this increase, the Optional State Supplement Payment Program amounts as of January 1, 2013 are as follows:
