RE: Cost of Living Increase for January 2014 and Maintenance of State
Supplementary Payment for January 1, 2014

The purpose of this transmittal is to inform Adult Foster Care Home Operators of the cost of living increase in federal Supplemental Security Income (SSI) payments. Effective January 1, 2014, the maximum SSI payment for an individual is \$721.00 a month and for an individual with an eligible spouse is \$1082.00 a month. DHCF will maintain the current Optional State Supplement payment of \$485 a month for calendar year 2014. Please see the below chart which outlines payments for providers and individuals/couples:
