SUBJECT: Correction to the Appendix K Rates Effective January 1, 2023.

Purpose

The purpose of this transmittal is to communicate a correction to the DD Waiver Appendix K rates that were updated effective January 1, 2023, through Transmittal 23-03 which Department on Disability Services (DDS) issued on May 3, 2023. It has come to our attention that a rate error occurred, resulting in an incorrect higher reimbursement rate for the per diem Supported Living and Residential Habilitation services.

The table below reflects the corrected Appendix K rates for Supported Living & Residential Habilitation per diem services that are affected by the rate error. These corrected rates are effective for dates of services rendered from January 1, 2023, until June 30, 2023.

Providers are not required to take any action at this time.
