SUBJECT: Clarification of Coverage of Over-the-Counter Narcan® Nasal Spray

Purpose

The purpose of this transmittal is to clarify the coverage of Narcan® (4 milligram naloxone hydrochloride nasal spray), following the recent approval by the U.S. Food and Drug Administration (FDA) to allow the sale of the drug without a prescription, or "over-the-counter" (OTC). Narcan® is an opioid antagonist indicated for the emergency treatment of known or suspected opioid overdose. The Department of Health Care Finance (DHCF) remains committed to addressing the evolving opioid epidemic by responding to providers' needs and concerns related to timely treatment access.

Details: Coverage of Over-the-Counter Narcan®

DHCF supports the recent FDA approval of OTC Narcan® and believes that this will help improve access to harm reduction and mitigate the risk of opioid overdose. However, if a beneficiary were to purchase Narcan® OTC, they would have to pay out of pocket for the cost of the drug. In order for a beneficiary to have minimal out of pocket costs, and a pharmacy to receive Medicaid reimbursement for Narcan®, the beneficiary must have a prescription for the medication. This requirement applies to both the Fee for Service Medicaid program and the Medicaid managed care program.

To receive Narcan® at no cost to the beneficiary, they may go to a pharmacy that has a standing order. Narcan® is available at no cost and no prescription at various pharmacies and community sites across the District as a part of the LiveLongDC campaign.
