The purpose of this transmittal is to notify Mental Health Rehabilitative Services (MHRS), Adult Substance Use Rehabilitative Services (ASURS), Free-Standing Mental Health Clinic (FSMHC), and Mental Health and Substance Use Disorder Supported Employment providers that the District of Columbia Medicaid Fee Schedule will be updated for the following services, covered under the State Plan.

Details

In accordance with requirements set forth in Section 9104 of Chapter 91 and Section 988 of Chapter 9 of Title 29 of the District of Columbia Municipal Regulations, the Department of Health Care Finance (DHCF) announces the Medicaid reimbursement rates for services as a result of the ongoing behavioral health rate study between the Department of Behavioral Health and DHCF.
