SUBJECT: Reimbursement Rate Changes for Behavioral Health Services Effective

November 1, 2023.

Purpose

The purpose of this transmittal is to notify Mental Health Rehabilitative Services (MHRS), Adult Substance Use Rehabilitative Services (ASURS), and Free-Standing Mental Health Clinic (FSMHC) providers that the District of Columbia Medicaid Fee Schedule will be updated for the following services listed in the body of the transmittal, covered under the Medicaid State Plan.

Details

In accordance with requirements set forth in Section 9104 of Chapter 91 and Section 988 of Chapter 9 of Title 29 of the District of Columbia Municipal Regulations, the Department of Health Care Finance (DHCF) announces the Medicaid reimbursement rates for the following services. The rate changes outlined in this transmittal are the result of the ongoing behavioral health rate study between the Department of Behavioral Health and DHCF.

Beginning November 1, 2023, DHCF will sunset HCPCS codes for MHRS and ASURS "Screening, Diagnostic Assessment" and "Medication Management" services, and transition to the use of CPT codes and Evaluation and Management codes, respectively, as described in the tables below. Historically, DHCF has used HCPCS codes to represent these services, which were reimbursed on a per-occurrence basis. The use of CPT codes will allow the services to be reimbursed based on the amount of time spent providing these services. DHCF is also aligning the rates for these services across MHRS, ASURS, and FSMHC provider types.
